We had an effective mid-year meeting in Cincinnati during the ACJS meeting. The necessary reports were made and the primary items of business were conducted. I will not repeat everything here. Essentially, the Association is financially well, the Journal is being published as desired, and the Association's business is being conducted.

I have two requests. First, we have one proposal for the meeting site for October 2009. It is Laredo, Texas proposed by Texas A&M University-International. We will be voting on the 2009 meeting location at the October 2008 annual meeting in Denver. Should any other location desire to compete to be the 2009 meeting location, a proposal needs to be sent to 2<sup>nd</sup> VP David Montague very, very soon.

Second, it is time to begin the search for a Journal editor. Jeff Walker graciously volunteered and was appointed to chair the Search Committee. Please, send nominations for the Editor to Jeff at the University of Arkansas, Little Rock. Self-nominations are acceptable. A formal job description and announcement of the opening is in the works.

You will find an advertisement for SWACJ coffee/travel mugs in the Newsletter. We have somewhere near 50 of these left from the October 2008 meeting. Rather than store them forever or attempt to ship them to Denver, the Executive Board has approved the sale of these to the membership. See the details in the ad. Buy one, Buy two, but please buy them. Maybe someone would like to purchase several to use as a gifts/awards for colleagues or as a way to encourage membership in SWACJ in your department. Graduate programs could give them to newly minted graduates to encourage their participation in professional associations where ever they may locate.

At the mid-year meeting, we increased the SWACJ membership dues as reported in the minutes. These go into effect with your 2008-2009 membership. Thus, if you pay membership for next year with your October 2009 conference registration, the new dues amount is in effect. Dues for this remaining part of 2007-2008 remain at the lower amount. Changes were also made in conference registration fees.

The journal is now listed in the on-line directory for on-line journals

Ebsco Host sent a 5 page contract that may not be in the journal's best interest so this is on hold

Journal publishers such as Rutledge and Sage only want journals that publish 4 times a year

Springer may take the journal at 2 times a year but ultimately wants 4 also
The journal could probably be expanded to 3 issues now but 4 is pushing
Will's term as editor expires in December so a committee needs to be formed to
find a new editor – Jeff Walker will chair the committee, Jim Golden and
Chip Burns will serve as members

Ronald Hunter – ACJS President and Wes Johnson – in-coming ACJS President dropped by to greet the group

An ad for SWACJ is in the ACJS Program – Ralph Rojas is no longer in Denver so will not be continuing as site chair

ACJS has moved to have more international ties

They are also moving to waive student membership fees if the students register for the conference

Mittie Sutherland is working hard on certification issues

National CJ Month – a bill is going to Congress at the end of March

Membership dues and conference costs: Phil Rhoades had a handout showing our membership rates compared to the other regions – ours are by far the lowest

The Executive Board recommends raising regular membership to \$40 and student membership to \$10 per year

# Regional Trustee Chip Burns

It was great seeing many of you at the ACJS annual meeting in Cincinnati. Attendance at the Cincinnati meeting was comparable to years past, as there were 1,415 attendees, compared to 1,437 at the 2007 annual meeting in Seattle. Hopefully, we can generate even greater support at the 2009 ACJS annual meeting in Boston (March 10-14). Let's do our best to support former SWACJ President Wes Johnson during his ACJS presidency by attending the annual meeting. Below I highlight recent ACJS happenings:

ACJS is financially healthy and appears financially stable for years to come. The Academy has made several strategic investments that have provided a greater level of financial comfort.

The Academy continues to be a "student friendly" organization. For instance, several students luncheons were provided free of charge in Cincinnati, and students were permitted to "work off" their registration fee by helping at the registration desk. The Executive Board agreed to provide free student membership to all students who register and pay for the upcoming annual meetings. Further, there are ongoing efforts to restore the Directory of Graduate Programs, and the Academy seeks to build relations with doctoral students and provide membership inducements for them.

ACJS continues to promote program Certification by offering information sessions and reviewer training at the regional meetings. Anyone interested in becoming a program reviewer or having their program reviewed should contact ACJS Executive Director Mittie Southerland (execdir@acjs.org).

In an effort to recognize the professionalism of our members, ACJS continues to examine the potential of establishing criteria for a Diplomate in Justice Science. If you are interested in serving on this committee, contact Past President of ACJS Ron Hunter at rhunter@wcu.edu.

ACJS recently endorsed Criminal Justice Month with the goal of promoting awareness of all things criminal justice. Congress is expected to consider March as Criminal Justice Month at the end of March 2008.

All members are encouraged to update their ACJS membership and are reminded that they are not permitted to serve on committees unless their membership is current.

ACJS has strengthened relations with related organizations at both the national and international levels. Since March 2007, ACJS has had representatives at the International Police Executive Forum, United Nations meetings in Geneva, and the Stockholm Prize Symposium. ACJS strengthened relations with the British Society of Criminology, the European Society of Criminology, and the Australia-New Zealand Society of Criminology, and the American Society of Criminology.

Please let me know if I can elaborate on any of these issues or if there's something you'd like brought to the attention of ACJS. It is a pleasure to serve as your Trustee.



#### Who is Eligible?

Undergraduate students currently enrolled (and those who will be enrolled September 2008) in a university, college, junior college or community college within the Texas Association of Criminal Justice Educators of the Southwestern Association of Criminal Justice.

#### **Presentation of submitted papers:**

Students are required to attend the Southwestern Association of Criminal Justice annual conference and present their papers to be eligible for the scholarships.

#### Awards:

Registration fee for the top two winners for the Southwestern Association of Criminal Justice annual conference.

#### **Criteria:**

- 1. The paper must be authored by student(s) only. No Faculty/student joint papers will be considered.
- 2. The paper must be an original work.
- 3. Undergraduate students currently enrolled (and those who will be enrolled September 2007) in a university, college, junior college or community college within the Texas Association of Criminal Justice Educators of the Southwestern Association of Criminal Justice.
- 4. The paper <u>must not</u> be a winner in the SWACJ Student Paper Competition.
- 5. Three copies of each paper must be submitted before **September 15, 2008** to the current president of the Texas Section:

The Southwestern Association of Criminal Justice is seeking applications for the position of Editor of the The Southwest Journal of Criminal Justice, an official publication of the Southwestern Association of Criminal Justice. The Editor's main responsibilities include soliciting articles, facilitating reviews of articles, and overseeing the overall publication of the online journal. The Editor will set editorial policy, select deputy and associate editors, create a peer review system, and manage the journal. Applications must meet the following criteria:

- Demonstrated record of scholarly activity as measured by such indicators as publications in refereed journals, book publication, and research;
- Earned doctorate or terminal degree (JD) in criminal justice or related field;
- Senior (associate professor or above) academic rank at host institution preferred but not required;
- Formal declaration of support from host institution, including release time, space, and other support services the institution will commit to editorship.

Those interested in being considered should provide a formal proposal to the Editor Selection Committee no later than **July 7, 2008**. The proposal should include:

- Statement of editorial philosophy for the journal;
- Statement of applicant's qualifications, including vita;
- Formal declaration of institutional support;
- A budget including a breakdown of the expenses that will be provided by the host institution and those expected for the Academy.

The Executive Board of SWACJ will appoint the Editor for a three-year term. Applications and requests for further information should be directed to:
